Pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we, Ashoka Buildcon Limited ("the Company") inform that as part of the strategic restructuring plan, the Company has sold its entire stake (100%) held in its 16 wholly-owned subsidiary companies, as per list enclosed hereto as **Annexure A**, to **Unique Hybrid Renewables Energy Private Limited**, another wholly owned subsidiary. ("Acquiring Subsidiary")

Further to inform that consequent to the completion of the above-referred sale, the Acquiring Subsidiary will become intermittent holding company ("**Holdco**") of the said 16 subsidiaries.
